MS. 164 Franklyn D. Berry Deed & Document Collection, 1849-1935

Scope and Content Note: The collection consists of 45 deeds and other legal documents, which were owned by Dr. Franklyn D. Berry of Westport, South Dartmouth, and Harwich, Massachusetts. The documents were collected by Elmer B. Lewis, and a number of the deeds and other documents are for land transaction between him and members of the Wixon family.

Historical and Biographical Information: One of the names frequently listed in the documents is Nehemiah Wixon. Nehemiah was born in 1827 and died in 1905. He was the son of Nehemiah and Charity Chase Wixon, and had two siblings: Sophronia Eldredge Wixon West (married to William Burgess West) and a brother George. He went to sea at age 9, and continued his maritime career until retirement in 1878, serving 24 years as a Master Mariner. In 1855, he built a house for his wife Amy (who died in 1895) on Lower County Road in Dennis. After retirement, Nehemiah ran a grocery store on the property until his death in 1905. Elmer Lewis (whose name appears on some of the documents, and whose collection this was before Franklyn Berry acquired it) bought the property and continued the grocery business until 1939 when he sold the business to Henry Carney, a physician. The grocery store was sold, and moved westerly away from the house. The property was eventually sold to Walter Crafts. He and his wife Lily owned and operated Walt & Lil's Chicken Coop Restaurant there from 1957 to 1982. In 2005, the house was purchased and renovated by Jeanne and Douglas MacArthur. The building that was once the Chicken Coop Restaurant is now the Wooden Shoe (2019).
