**Biographical note**: Jonathan Higgins was born in Orleans on November 21, 1816. He was educated in Orleans public schools and studied law at Rock Harbor Academy under Judge J.M. Day in 1858. He was elected for 3 terms as Registrar of Probate (Barnstable County) and was elected to the Legislature in 1876. He was a deacon of the Orleans Congregational Church and handled many administrative tasks for the church including that of treasurer. Higgins also provided a similar service for the Orleans Cemetery Association. He first married Mary Doane, daughter of Captain Seth Doane, with whom he had seven children. Some time after Mary passed away he married his second wife, Ruth Snow, daughter of Joseph Snow, but it is uncertain if he had children from his second wife. For many years he lived on Pond Street, Orleans, Massachusetts, where he had a small office for his law practice.

**Scope and contents note:** The collection consists of correspondence, an account book and legal documents and receipts relating to Jonathan Higgins' Orleans law practice. There are a small amount of items relating to his involvement with the Orleans Congregational Society Church. The remainder of the collection consists of 54 deeds recording land transactions in Barnstable County. The majority deal with property in Provincetown, Massachusetts and date between 1820 and 1891, and also apparently relate to Jonathan Higgins' law practice.
