Scope and Content Note: This collection consists of deeds, documents and one ledger. The deeds are organized by town and include Barnstable, Harwich, Orleans, Dennis on Cape Cod, Massachusetts. The names found on the deeds are from the Kenney, Cobb, Bacon, Howes, Fish, Tupper, Swift, Otis, Nickerson, Crowell, Dixon and Whittemore families. The documents are eclectic and include a petition to Judge Daniel Davis (1793), and a Barnstable Town Meeting Notice (1704), as well as probate documents for the Kenney family. The ledger is that of Ephraim Richardson who owned an interest in many ships. It also details his personal property and that of his daughter.
